General Consent

I or we understand that all physically strenuous activities are potentially dangerous, and serious and sometimes fatal injuries occur when engaging in the available activities offered at WF&F. I or we specifically assume any and all risks of injury. I or we hereby waive, release and discharge any and all claims that may have or may subsequently acquire against WF&F, its directors, officers, agents, employees, personal trainers, or instructors. This release and waiver is intended to discharge, in advance, any and all potential liability arising out of or connected in any way with membership and participation at WF&F. It is further understood that my waiver, release, and assumption of risk is to be binded in my heirs and assigns.
